MANUFACTURING AND PACKAGING (A1-A3)

The environmental impacts considered for the product stage cover the manufacturing of raw materials used in the production as well as packaging materials and other ancillary materials. Also, fuels used by machines, and handling of waste formed in the production processes at the manufacturing facilities are included in this stage. The study also considers the material losses occurring during the manufacturing processes as well as losses during electricity transmission.

A market-based approach is used in modelling the electricity mix utilized in the factory.

Manufacturing stage (A1) encompasses various raw materials where sand serves as primary aggregate with 8% production losses and 248 km transport distance. Vinnapas represents material with 21% production losses and 1413 km transport distance from Germany. Limestone powder contributes with 0.3% losses and 206 km transport.

Cement-based materials include granulated blast furnace slag with 3% losses and 163 km transport. Portland cement with 4% losses and 98 km + 141km transport from Sweden, and Anhydrite with 4% losses and 1215 km transport from Germany. Aluminate cement represents the most transported component with 44% production losses and 599 km + 8200 km transport distance from Turkey.

Material losses vary significantly between different components, from 0.3% to 44%, reflecting different processing complexities. Transport distances range from 98 km + 141km for local Portland cement to 1413 km for specialized copolymer materials.

Packaging stage (A3) includes production of EU-pallets contributing 0.2% loss, paper production for paper bags contributing 0.1% loss, and production of plastic bags contributing 0.4% loss.

All packaging materials show minimal production losses below 1.5%. Energy use (A3) includes electricity consumption from Sweden's energy mix 2022 with 0.1% CO₂e emissions. The energy profile follows IEA2022 standards.

TRANSPORT AND INSTALLATION (A4-A5)

Transportation impacts occurred from final products delivery to construction site (A4) cover fuel direct exhaust emissions, environmental impacts of fuel production, as well as related infrastructure emissions.

For transport to the construction site (A4), there is 1,0031 kg of transported mass with an average transport distance of 150 km. For installation (A5), there is Market for tap water as an installation resource with 0,18 kg.

Installation assumes 0% material loss during application. Installation packaging waste includes plastic packaging (0,00032 kg), wood packaging (0,0025 kg), and paper packaging (0,00029 kg), which are processed according to EU standard scenarios with transport distances following constituent database values for packaging waste treatment facilities.

PRODUCT USE AND MAINTENANCE (B1-B7)

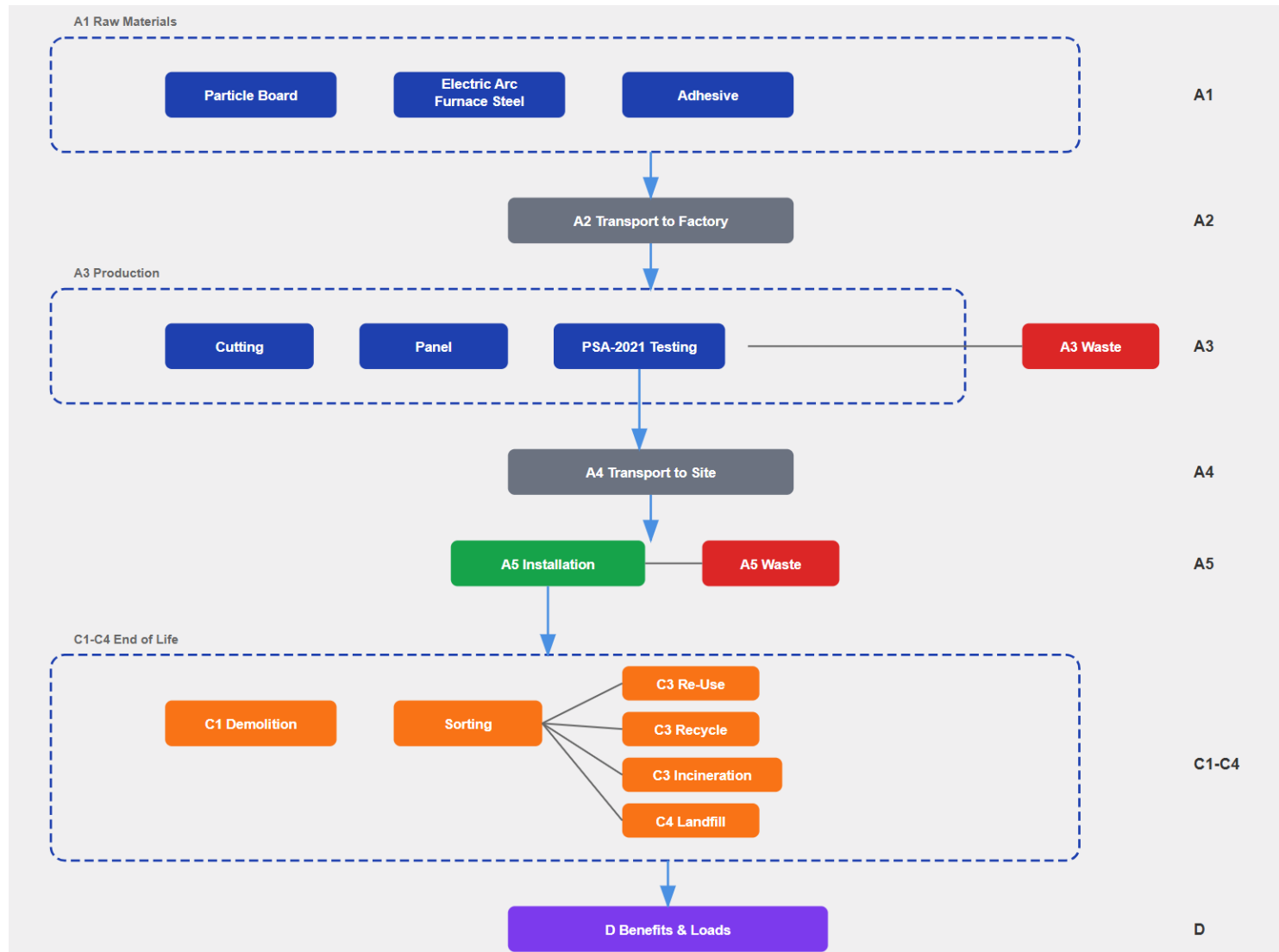
This EPD does not cover the use phase. Air, soil, and water impacts during the use phase have not been studied.

PRODUCT END OF LIFE (C1-C4, D)

For stage (C1-C4), demolition and dismantling are modeled with 0.01 kWh diesel consumption in construction machinery for demolition work. The concrete waste amounts to 1.18 kg per declared unit, which corresponds to approximately 6% of the total emissions at end of life. Transport to waste management (C2) and waste processing (C3-C4) follow constituent database values with standard treatment scenarios assuming concrete recycling..

For module D, the environmental benefits arise from recycling 0,688 kg concrete, 0.0025 kg for EU pallet, 0.00032 kg for plastic packaging, and 0.00029 kg for paper packaging.

LIFE-CYCLE ASSESSMENT

CUT-OFF CRITERIA

The study does not exclude any modules or processes which are stated mandatory in the reference standard and the applied PCR. The study does not exclude any hazardous materials or substances. The study includes all major raw material and energy consumption. All inputs and outputs of the unit processes, for which data is available for, are included in the calculation. There is no neglected unit process more than 1% of total mass or energy flows. The module specific total neglected input and output flows also do not exceed 5% of energy usage or mass.

The production of capital equipment, construction activities, and infrastructure, maintenance and operation of capital equipment, personnel-related activities, energy and water use related to company management and sales activities are excluded.

VALIDATION OF DATA

Data collection for production, transport, and packaging was conducted using time and site-specific information, as defined in the general information section on page 1 and 2. Upstream process calculations rely on generic data as defined in the Bibliography section. Manufacturer-provided specific and generic data were used for the product's manufacturing stage. The analysis was performed in One Click LCA EPD Generator, with the 'Cut-Off, EN 15804+A2' allocation method, and characterization factors according to EN 15804:2012+A2:2019/AC:2021 and JRC EF 3.1.

ALLOCATION, ESTIMATES AND ASSUMPTIONS

Allocation is required if some material, energy, and waste data cannot be measured separately for the product under investigation. All allocations are done as per the reference standards and the applied PCR. In this study, allocation has been done in the following ways:

This EPD is product and factory specific, representing a weighted average of the same product manufactured at our two production facilities, one located in Bålsta and one in Backamo. The climate impact varies only marginally between the factories (approximately ±4,95% for GWP-fossil A1-A3), which can primarily be attributed to minor differences in energy consumption and transport distances for raw materials. This variation complies with the requirements in GPI 2.9.

LCA SOFTWARE AND BIBLIOGRAPHY

This EPD has been created using One Click LCA EPD Generator. The LCA and EPD have been prepared according to the reference standards and ISO 14040/14044. The EPD Generator uses Ecoinvent v3.10.1 and One Click LCA databases as sources of environmental data. Allocation used in Ecoinvent 3.10.1 environmental data sources follow the methodology 'allocation, Cut-off, EN 15804+A2'.

ENVIRONMENTAL IMPACT DATA

The estimated impact results are only relative statements which do not indicate the end points of the impact categories, exceeding threshold values, safety margins or risks.
